

**REPORT/ RECOMMENDATION TO THE BOARD OF COMMISSIONERS OF

SUBJECT: Airport Coronavirus Response Grant Program (ACRGP) Grant Offer

RECOMMENDATION: Motion to Approve ACRGP 3-08-0029-054-2021-Grant Agreement in the Amount of \$57,000 and Authorize the Chair to sign.

BACKGROUND: Congress passed and the President signed the Coronavirus Response and Relief Supplemental Appropriations Act on December 27, 2020 to provide more assistance to individuals and businesses harmed by the coronavirus COVID-19 pandemic. The Act includes \$900 billion in supplemental appropriations for COVID-19 relief and includes nearly \$2 billion in funds to be awarded as economic relief to eligible U.S. airports and eligible concessions at those airports to prevent, prepare for, and respond to the COVID-19 pandemic. The Federal Aviation Administration has established the Airport Coronavirus Response Grant Program to distribute the funds. This grant program will provide up to \$1.95 billion for primary commercial services airports and non-primary commercial service and general aviation airports will share \$45 million based on their airport categories, such as National, Regional, Local and Basic. Of that \$45 million, airports that participate in the FAA Contract Tower Program will divide \$5 million equally.

Centennial Airport upon acceptance of the grant will receive \$57,000 to be allocated for operating expenses incurred because of the economic impacts due to the coronavirus.

The same grant agreement will also have to be approved by the Arapahoe County Board of Commissioners as sponsor of the Arapahoe County Public Airport Authority.

Staff recommends approval of ACRGP 3-08-0029-054-2021-Grant Agreement in the amount of \$57,000.

FINANCIAL DATA: Upon approval, and after a request for reimbursement the airport authority will receive \$57,000.
