**SUBJECT:** Straight Flight, Inc - Reapplication under Centennial Airport's Minimum Standards for Commercial Aeronautical Activities.

**RECOMMENDATION:** Motion to approve the reapplication from Straight Flight, Inc. and authorize the Chairman and Clerk to sign the associated 10-year Agreement Under Standards.

**BACKGROUND:** On 5/12/2020, Straight Flight, Inc., a wholly owned subsidiary of Sierra Nevada Corporation ("the Applicant"), re-applied to continue its authorization to conduct Airframe and Powerplant Repairs as defined under Part 3 Sections (3) of Centennial Airport's Minimum Standards for Commercial Aeronautical Activities (the "Standards").

The Applicant has operated its Airframe and Powerplant Repairs business continuously at Centennial Airport since 1990 and their current 10-year agreement with the Authority expires on June 9, 2020.

The Principal owner is Sierra Nevada Corporation, and key employees are Chris Haight as the General Manager and Harry Grinton as Shop Manager both with over 30 years experience. The business is open Monday through Friday, 7am to 6pm.

The Applicant's premises, hangar keepers, and products and completed operations insurance coverage meets the minimum standards insurance requirements.

This reapplication is satisfactory and meets all requirements of the Standards. A copy of the reapplication, exhibits, and the standard form Agreement under Standards contract are attached for your review.

As there are no changes in the scope of service, a Public Hearing is not required.
